- Validity:**
- 10 years - Age 16 & Older
  - 5 years - Under Age 16
- Issued by:** U.S. Department of State
- Limitations:** Not valid for international air travel

## Enhanced Driver's License

- Cost:**
- \$15 - \$30 over a regular driver's license
- Validity:**
- Will vary by state or province
- Issued by:** Individual state or province
- Limitations:** Not valid for international air travel
- Info:** Visit your state or provincial government website



## U.S. Passport

- Cost:** \$100 (age 16 and older); \$85 (under age 16)
- Validity:** 10 years (adults); 5 years (under age 16)
- Issued by:** U.S. Department of State

## Canadian Passport

- Cost:** \$87 (age 16 and older); \$37 (ages 3-12); \$22 (under age 3)
- Validity:** 5 years (age 3 and older); 3 years (under age 3)

*For pre-approved, low-risk travelers crossing the U.S./Canada border*



**NEXUS Card\***

\* Requires additional application processes, including an interview and fingerprinting.

**Added Benefits:** Access to dedicated commuter lanes on the northern border and expedited marine reporting; access to NEXUS kiosks at designated Canadian airports

**Total Cost:** – \$50.00

**Validity:** 5 years

**SENTRI Card\***

\* Requires additional application processes, including an interview and fingerprinting.

**Added Benefits:** Access to dedicated commuter lanes on the southern border

**Total Cost:** – \$122.25

**Validity:** 5 years

## Trusted Traveler Programs

*For pre-approved, low-risk commercial truck drivers crossing either the northern or southern border at dedicated lanes*



**FAST/EXPRES Card\***

\* Requires additional application processes, including an interview and fingerprinting.

**Added Benefits:** Access to dedicated lanes for commercial shipments on both the northern and southern borders

**Total Cost:** – \$50.00

**Validity:** 5 years

**Issued by:** U.S. Customs and Border Protection

Beginning June 1, 2009, U.S. & Canadian citizens under the age of 16, or under the age of 19 if traveling with a school, religious, or other youth group, may present a birth certificate, Consular Report of Birth Abroad, Canadian Citizenship Card, or a naturalization certificate. Birth certificates can be an original, photocopy, or certified copy.
